#### The Foreword

- f) How do differing approaches to cybersecurity and consumer protection in various Southern African Development Community (SADC) countries affect innovation in the provision of cross-border digital services and products; and
- g) What is the role of digital ethics and data privacy in digital regulation and how can they be integrated in regulation to achieve responsible innovation?

I welcome you all to the "Innovation for Better Regulation" workshop and look forward to the great discussions and shared insights of innovative ideas that will shape the future of regulation of the communications sector in the SADC. It is my hope that we can collectively work towards creating a regulatory environment that is not only flexible and responsive to change but also the conduit of innovation.
